Note regarding Term Dates: Term fees will not alter each term depending on the number of weeks per term. Over the page is our Pricing Structure of fixed pricing per term throughout the year. The number of weeks per term always equates in a total of 40 weeks in the year of tuition, therefore balances out.

ANNUAL REGISTRATION FEE: A once off registration fee of \$48 Inc GST is required from each student to commence their tuition at Studio V. This registration fee covers administration fees throughout the year, APRA Music Licensing and contributes to the student's ever increasing public liability insurance costs.
